Sub: Election of Board of Directors of Sardar Patel Co-operative Dairy Federation Limited (SPCDF).

1. In accordance with the provisions of Section 45k of the Multi State Cooperative Societies (amendment) Act, 2023, read with its Rule 19 framed under the Act, the Office of the Cooperative Election Authority (CEA), Ministry of Cooperation, Government of India vide its letter CEA-12011/449/2025 dated 30/01/2026, has appointed undersigned as the Returning Officer to conduct the elections of the Board of Director of SPCDF.
2. In line with the timeline provided by the CEA and relevant provisions of the MSCS (Amendment) Act, 2023, its associated Rules, and SPCDF bye laws, the undersigned issued notices announcing the election schedule and conducted subsequent communications accordingly.
3. Total fourteen(14) delegates, 11 from Class-1 members and 3 from Class-2 members filed their nominations to contest for the election of the Board of Director of SPCDF out of the total seats of 14 elected directors (11 Class-1 members and 3 Class-2 members) as per bye laws clause No.38 (2) in the board. Hence, all of them were elected unopposed.

4. As Stipulated by the Cooperative Election Authority, the undersigned vide letter dated 22/04/2026 sent the filled in format under Rule 19(M) to Cooperative Election Authority for seeking approval for the declaration of the election result of Board of Directors of SPCDF. Subsequently, the authority provided its approval vide letter CEA-12011/449/2025 dated 24th April, 2026.

5. Consequently, the final result pertaining to election of Board of Director of the SPCDF is declared, as per the details provided below.
